Session, 191

Harlan, Iowa, August 8, 1913

The Board of Supervisors met today in called session with all members present. The minutes of the previous meeting were read and approved.

With reference to the claims of Melton and Steen, Supervisor Brodersen was appointed as a committee to confer with the Crawford County Board of Supervisors.

The Board then began the auditing of claims.

Be it resolved by the Board of Supervisors of Shelby County, Iowa, that it is deemed advisable and necessary to construct the following described bridges and culverts:
