

## Supervisors' Minute Book, No. 7, Shelby County, Iowa.

Session, 191

Harlan, Iowa, April 28, 1915

The Board of Supervisors met today with all members present, except Chairman Pryor.

The Minutes of the previous meeting were read and approved.

The first quarterly report of Henry F. Wunder, County Recorder, was approved by Geo. E. Miller, chairman pro tem.

## Report of County Recorder.

I, the undersigned, Henry F. Wunder, County Recorder of Shelby County, Iowa, do hereby certify and report that during the quarter year ended March 31, 1915, I collected as fees for recording instruments of record as provided by law, the sum of \$575.30. The Board of Supervisors met today with all members present.

The minutes of the previous meeting were read and approved.

The claim of Hugh Daugherty for damage caused by runaway team in Greeley township was referred to County Attorney Hertert for investigation and report.

The Board approved the bond of Geo. W. Ickes as Soldier's Relief Commissioner in the sum of \$500.00.

The Board approved the lease with H. W. Buckman for additional land for road in Sec. 18-80-38.

The Board then took up the auditing of claims.

On motion Board adjourned to 1:00 o'clock P. M.

The Board met at 1:00 o'clock P. M. as per adjournment.

The County Auditor was directed to pay to J. A. Grabill the sum of \$50.00 per month for the care of his father, S. Grabill, until other arrangements can be made for his keep. This allowance to begin with May 15, 1915.

The Board then took up the auditing of claims and in due time completed same. (For list of claims audited and allowed see Claim Register No. 8.)

Proof of Publication being on file the Board on motion granted the Petition of the Town of Irwin, Iowa, for authority to erect and maintain poles, wire and appliances along and upon certain highways in Jefferson Township, Shelby County, Iowa, same to be granted for a period of twenty years.

The Board of Supervisors on motion adjourned sine die.
