Session, 191

Harlan, Iowa, July 27, 1915

The Board of Supervisors met today with all members present.

The minutes of the previous meeting were read and approved.

The records of the Board of Supervisors of Shelby County, Iowa, for the regular March, 1915, session, commencing on the 26th day of March, 1915, is hereby amended by inserting of the said session of the said Board on July 27, 1915, the following, to-wit:

Be it resolved by the Board of Supervisors of Shelby County, Iowa, that the minutes of the session of the said Board of Supervisors of Shelby County, Iowa, at the March, 1915, session thereof, be amended by inserting therein and adding thereto as of the regular March, 1915, session of the said Board of Supervisors aforesaid, the following:

Be it resolved by the Board of Supervisors of Shelby County, Iowa, that all culverts which have been contracted for by virtue of a certain contract made and entered into by and between Shelby County, Iowa, by its Board of Supervisors and the Lana Construction Company of Council Bluffs, Iowa, on March 26, 1915, shall be paid for out of the County Road Funds of this county as provided by the Acts of the 35th General Assembly.

Be it further resolved by said Board of Supervisors that said amendment to the minutes of said March session, 1915, is made in accord with the agreement made at said March session, with the said Lana Construction Company, which agreement was omitted from the minutes of said session through an omission.

Be it further resolved by said Board of Supervisors that the County Auditor of said County is hereby directed to make the correction and amendment hereinbefore set out, and said amendment is hereby ~~confirmed~~ confirmed, approved and established, and the same is hereby made a part of the records and minutes of the proceedings of the said March, 1915, session of said Board, and the said minutes and records are amended accordingly as of and from March, 1915, session of said Board.

The Board of Supervisors on motion instructed the County Auditor to advertise for bids for County Road work and hill cutting on the Pickard Hill on the Harlan-Defiance road, and the Schwab Hill on the Harlan-Jacksonville road.

The Board on motion adjourned to 9:30 A. M. August 13, 1915.
