

Supervisors' Minute Book, No. 7, Shelby County, Iowa.

Session, 191

Harlan, Iowa, May 6, 1919

The Board of Supervisors met today as per adjournment, with members Hans Brodersen, Geo. E. Miller and N. H. Johnson and County Auditor Glen P. Howard present.

The minutes of the previous meeting were read and approved.

This being the day set for the receiving of bids on circular culverts the same were opened and read. Bids were on file by the followings concerns: Klauer Mfg. Co., Dubuque, Iowa; Russell Grader Mfg. Co., Minneaploils; Iowa Pure Iron Co., Des Moines; Wilson Concrete Co., Red Oak, Iowa; Lana Const. Co., Council Bluffs; Wickham Bridge & Pipe Co., Council Bluffs.

On motion the contract for Corrugated Culverts with awarded to the Iowa Pure Iron Co., of Des Moines, Iowa, at the following prices:

The bond of the Iowa Pure Iron Co., was fixed at \$1700.00.

On motion the contract for re-inforced concrete culvert pipe was awarded to the Lana Construction Col of Council Bluffs, Iowa, at the following prices:

The bond of the Lana Construction Co. was fixed at \$2000.00.

The Board of Supervisors authorized the County Auditor to refund to L. J. Smith the sum of \$ 6.89 on account of an erroneous tax sale of Lot 9 in Blk 2, Tennant and Lots 6 & 7 in Blk 6, Tennant on Dec 2, 1918. Ref. # 192

The Board on motion adjourned to 1:30 o'clock P. M.

The Board met at 1:30 o'clock P. M. as per adjournment.

The County Auditor was directed and authorized to draw warrant from the County Fund in favor of Wm. J. Lewis, County Chairman, as a donation by Shelby County to the celebration of Homecoming Day for the Soldiers, Sailors, Marines and Nurses of the County to be held on May 29, 1919. MM # 312

It was ordered by the Board that the County Auditor draw warrant on the Poor Fund of the County to pay the tax of Mrs. Margaret Knouse, she being unable to contribute to the public revenue. PD MM # 540

The Board on motion adjourned to May 7, 1919 at 9:00 o'clock A. M.

Harlan, Iowa, May 7, 1919

The Board of Supervisors met to 9:00 o'clock A. M. as per adjournment with members Hans Brodersen, Geo. E. Miller and N. H. Johnson and County Auditor Glen P. Howard present.

The Board approved the quarterly report of W. B. Woods, Recorder, which shows fees collected in the sum of \$563.00. Treasurer's receipt for said amount attached thereto and same was properly acknowledged.

The County Auditor was ordered to cancel the assessment of the Shelby County Savings Bank for the reason that they had not deducted their Liberty Bonds when figuring their assessment. (Year 1919)

The Board ordered the County Auditor to issue warrant drawn on the Orphans Home Fund in favor of Elim Orphanage, Elk Horn, Iowa, in the sum of \$250.00. PD MM # 55

The Board then took up the auditing and allowing of claims which work was in due time completed and the Board adjourned to June 2, 1919. (For list of claims audited and allowed see Claim Register No. 9.)
