Harlan, Iowa, June 12, 1919

The Board of Supervisors met today with members Hans Brodersen and Geo. E Miller and County Auditor Glen P. Howard present.

The minutes of the previous meeting were read and approved.

The Board took up the settlement with J. T. Newby, County Treasurer and continued this work until noon when they adjourned to 1:30 o'clock P. M.

The Board met at 1:30 o'clock P. M. as per adjournment.

The Board annulled certain contracts made in 1917 with the Lana Construction Company of Council Bluffs, Iowa, for three box culverts in Shelby County, and immediately entered into new contract with the same firm for box culverts at following prices:

5x5-44' concrete box	N. line Sec. 4, Shelby Twp.	\$1300.00
6x6-50' concrete box	Bet. 24-25' Washington Twp.	1840.00
5x5-36' concrete box	Bet. 15-22 Union Twp.	1150.00

The bond of the Lana Construction Co. was fixed at \$4290.00.

The Board completed the settlement with the County Treasurer and found that he had in his possession on May 31, 1919, the sum of \$141,784.95, which amount was produced in sworn statements of the various depositories.

The salary of the Deputy Treasurer was fixed at \$125.00 per month. This order to be in effect from June 1, 1919.

The salary of the Deputy Clerk of the District Court was fixed at \$125.00 per month,. This order to be in effect from June 1, 1919.

The Board on motion adjourned to July 7, 1919.

The Board approved the quarterly report of the Clerk of the District Court which report shows fees collected and turned in to the County Treasurer in the sum of \$643.80.

The bond of the Lana Const. Co., for the construction of certain concrete box culverts in the sum of \$2200.00 was on motion approved.

The Board adjourned to 1:30 o'clock P. M.

The Board met at 1:30 o'clock P. M.

The Board authorized the County Auditor to draw warrant/monthly on the Poor Fund in favor of Jos. F. Beh in the sum of \$10.00 for house rent for Mrs. Nettie McConnell.

The Board then took up the auditing of claims which work was continued until time for adjournment.

The Board on motion adjourned to July 8, 1919.
