SHALL THE FOLLOWING PUBLIC MEASURE BE ADOPTED:							
<p>Shall the IKM Community School District and the Manning Community School District be reorga-nized to form a new school district known as the IKM - Manning Community School District to include all of the territory of the IKM Community School District and the Manning Community School District as legally described in the published Decision of the Board of Directors of Loess Hills Area Education Agency 13 and Heartland Area Education Agency 11 regarding the Petition for the Reorganization of the IKM Community School District and the Manning Community School District-, shall the initial board of directors be comprised of seven (7) directors appointed in accordance with Iowa Code Section 275.41, with three (3) directors appointed by the IKM Community School District Board of Directors, three (3) directors appointed by the Manning Community School District Board of Directors, and one (1) director appointed by the members of the initial board, or, in the absence of such appointment, by special election, and shall the proposed school district be governed thereafter by a regular board of directors comprised of seven (7) directors, and shall the method of election for the regular board be the election of seven (7) directors, with four (4) directors being residents of two multi-member director districts and three (3) directors elected at large, and with all directors elected by the electors of the entire district as set forth in Iowa Code Section 275.12(2)(c)?</p>
